MTNA Competitions

MTNA Competition is now available to register. You can access registration at https://members.mtna.org/ MTNACompetitions2020/Registration/. Please note you DO NOT have to send your video with your registration. We will request your video submissions at a later date. Entry deadline is September 16, 2020 at 12pm Pacific Standard Time

This year the Nevada State Competition will be conducted virtually. As you are getting ready to register your students in the competition, Here are a few tips about how to record and submit your videos for the competition.

- 1. All competitions are conducted via video round. You will be uploading your videos on YouTube. If you do not have a YouTube account this is a good time to create one by going to www.youtube.com. If you have an YouTube account, be sure your username does not contain the teacher's name or the competitor's name. You can simply go to "setting" to change your username.
- 2. As you begin your recordings in the weeks to come, remember each video should only have ONE PIECE. Multiple movements within a piece may be recorded in one video (eg. Beethoven Sonata Movement 1 and 2) unless the movement that is more than 10 15 minutes. On the "title" list your Contestant Number, videos x/x, (for example, Junior Woodwind #2, Video 2 of 5); List the title of the piece, composer and movement on the "description" column (eg., Concerto in D Major, K 313_1. Allegro Maestoso_Wolfgang Amadeus Mozart). You do not have to record your entire program in one take. No student's name or teacher's name should appear on the video.
- 3. Please list your video as "unlisted."
- 4. It is best to record with your video camera or phone placed horizontally. We need to see the contestants full body (face, hands on the instrument and feet). The ideal recording resolution is 1080p or higher. Pianists please place your camera so it captures your side profile, please do not film with your back facing the camera. To observe the CDC guideline we suggest instrumentalists with accompanists six feet apart. Senior piano duet team may use two pianos to perform their duet pieces.
- 5. Please DO NOT edit your video, which include adding titles, fade outs, effect, reverbs, audio does not match video etc. You will be asked to re-record your video if this occurs.
- 6. Once finished please send an email with all the YouTube links to Jee Wong jeekwong@aol.com (piano and woodwind contestants) and Julian Lam Julianlam@aol.com (string and voice contestants). Please include your contestant number on the email you sent out.
- 7. You should record the entire program even if your program exceeds the maximum time allowed by MTNA (Juniors 20 minutes, Seniors and Senior Piano Duet 20 25 minutes, Collegiate 30 minutes).
- 8. We will be sending out a program with YouTube links to all contestants when we announce the result. To respect your privacy, If you prefer not to have the YouTube link included in the program, please let us know on the final email you send to us with YouTube links.
- 9. Occasionally YouTube will block your videos (sound and visual) when they contain copyrighted materials. Should this happen please let me know and I will find an alternate way for you to upload your videos. It is always a good idea to double check and make sure your videos are not censored by YouTube before you send us the links via final email.
- 10. Especially for pianists, we recommend you find the best instrument you can to record your program. Use an instrument that will properly express your tone, dynamics, and technique. If you need a studio to record your program, please let us know and we can arrange that with no charge, all you have to do is to provide your own recording equipments. Please note that the adjudicators are primarily evaluating each artist's performance, technique, and interpretation. The audio/video quality is of secondary importance.

- 11. There will not be an "Extra State Fee" this year since we are not using any physical facility to conduct the competition.
- 12. You do not have to provide printed/digital copies of your pieces for the judges. In rare occasion if the judges could not find the score on their own and are needing music to properly adjudicate your performance, we will reach out to you on a case by case basis.
- 13. You must upload the videos by October 24th at 12.00 Pacific Standard Time. Result will be announced via email between November 1st 7th or earlier.

I want to thank you for your attention and your flexibility as we navigate through this challenging time putting this competition together. Please reach out to myself or Julian if you have any questions about the recording and the competition.

Silver State Competition



Commitment to Students

The teacher shall conduct the relationship with students and families in a professional manner.

The teacher shall respect the personal integrity and privacy of students unless the law requires disclosure.

The teacher shall clearly communicate the expectations of the studio.

The teacher shall encourage, guide and develop the musical potential of each student.

The teacher shall treat each student with dignity and respect, without discrimination of any kind.

The teacher shall respect the student's right to obtain instruction from the teacher of his or her choice.

Commitment to Colleagues

The teacher shall maintain a professional attitude and shall act with integrity with regard to colleagues in the profession.

The teacher shall respect the reputation of colleagues and shall refrain from making false or malicious statements about colleagues.

The teacher shall refrain from disclosing sensitive information about colleagues obtained in the course of professional service unless disclosure serves a compelling professional purpose or is required by law.

The teacher shall participate in the student's change of teachers with as much communication as possible between parties, while being sensitive to the privacy rights of the student and families.

Commitment to Society

The teacher shall maintain the highest standard of professional conduct and personal integrity.

The teacher shall accurately represent his/her professional qualifications.


The teacher shall strive for continued growth in professional competencies.
